The International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, 1978 (STCW 1978), was adopted by the International Conference on Training and Certification of Seafarers on 7 July 1978 and entered into force on 28 April 1984.

On 22 May 1991 the Maritime Safety Committee adopted amendments to STCW 1978 by resolution MSC.21(59), in accordance with article XII(1)(a)(iv) of the Convention. The amendments entered into force on 1 December 1992.

This publication contains a consolidated text of STCW 1978, incorporating the above amendments.
